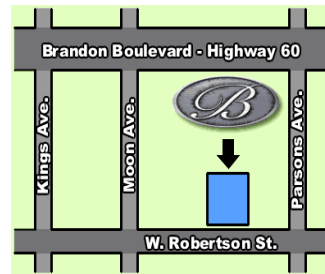

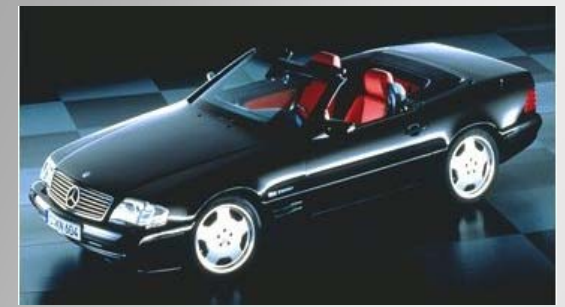

It's Good To Know What to Do after an Auto Accident?

Even the most careful drivers may be involved in an auto accident. Knowing what to do after the accident can make the experience a little less frightening, less inconvenient and decrease the chance of unnecessary costs and complications. Keep this report in your glove compartment in case of an accident. Use it to record critical information at the scene of the accident or as soon afterwards as possible. **After an Accident:**

- Stay Calm. Check for injuries. Life and health are far more important than damage to vehicles.
- Call the police, if any injury has occurred or if property damage was sustained.
- Get the facts. Write down the names, addresses, and license numbers of persons involved in the accident. Also, write a description of the other vehicle(s) and specific damages to all vehicles.
- Witnesses! Write down names and addresses of anyone who may have witnessed the accident. This can prevent disagreements concerning how the accident actually happened.
- Contact **Brandon Paint & Body** to assist you to arrange towing and rental car (if needed) and to prepare a comprehensive assessment of your damages and an estimate of repair.
- Do write down details about the accident, the location, and circumstances such as weather conditions and visibility. Do report your claim immediately.
- Report your claim to the insurer and let them know where it's located to be inspected.
- Don't sign any document unless it is for the police.
- Don't admit liability or fault at the scene or at any other time.
- Do not allow an insurer to send you to a repairer of their choosing, select one you can trust to work for you; **Brandon Paint & Body is ready to assist you!**

In the space provided, draw a detailed diagram of the accident, which includes placement of the vehicles involved before, during, and after the accident. In addition, if you notice any skid marks, lights, stop signs, etc., make sure that you include them as well. Lastly, if you have a camera or picture phone, make sure that you take photographs of the vehicles and the accident scene because these may be needed later.
